<p>2. <b>Stimulus Checks</b> – If eligible, have you received all 3 stimulus checks?</p>	<ul style="list-style-type: none"> <li>• If you have not received the <b>latest payment in March/April 2021</b>, go to <a href="https://www.irs.gov/coronavirus/get-my-payment">https://www.irs.gov/coronavirus/get-my-payment</a> to find out if eligible</li> <li>• To receive the <b>1st and/or 2nd stimulus payments</b> (which were paid out in 2020), you must file a 2020 tax return</li> <li>• For free help filing: Go to Pittsburg VITA site - Self-Help Federal Credit Union 2110 Railroad Ave., Suite 100 Pittsburg, CA 94565 for Virtual Tax Preparation &amp; Drop Off (any weekday) February 5th through May 17, 2021. <p>3. <b>Utility/Rent Assistance</b> – Have you been affected by COVID-19 and need help with rent or utilities?</p>	<ul style="list-style-type: none"> <li>• If you are unable to pay rent/utilities or past due rent/utilities, apply to <a href="https://housing.ca.gov">housing.ca.gov</a> or to call 1(833) 430-2122 for up to 12 months of assistance with rent/utility payments.</li> <li>• If not able to apply on-line, call 1(833) 687-0967 and a representative will help you apply over the phone</li> </ul>
<p>4. <b>Declaration of Inability to Pay Form</b> - If you have been unable to pay rent and have received an Eviction Notice or Notice to Pay or Quit, have you completed the Declaration of Inability to Pay form and given it to your landlord?</p>	<ul style="list-style-type: none"> <li>• If not, be sure to complete as soon as possible after receiving Eviction Notice or Notice to Pay or Quit and to give to your landlord. Save a copy for yourself as proof.</li> <li>• You have 15 days to complete and give to landlord after receiving a notice</li> <li>• If you have not been given form by landlord, you can download it from: <a href="https://housing.ca.gov/tenant/forms.html">https://housing.ca.gov/tenant/forms.html</a></li> <li>• For more information on resources and eviction protections, go to <a href="https://housing.ca.gov">housing.ca.gov</a></li> </ul>
