
There is another document that states that attending Mass together, eating together and doing other activities as a group can count as a meeting.

# **Examining Frederic Ozanam's Family Life**

A talk was given at the St. Louis National Assembly by National Council President Ralph Middlecamp.

Our founder was a prolific letter writer, and after his death, his wife collected many of the letters he wrote to friends and family. Ralph read some that Frederic and his wife wrote, showing how they were just like us. When Blessed Frederic moved to Paris to study at the Sorbonne, he wrote a letter to his father complaining that it was a 15-minute walk from the

room he was renting to the law school. And like all college students, he asked that more money be sent to him. Later, he made the acquaintance of Andre-Marie Ampere (whom the electric amp was named after) and rented a room from him. He wrote his family how much happier he was with his new lodging since it was only a five-minute walk to school and, of course, asked for more money. Ralph then showed us a map of Paris, which showed that Frederic had only moved a couple of blocks and was still the same distance from the law school.

Then he read a letter from Amelie to her mother complaining about how when she told Frederic before their marriage that his room was a mess, with the floor covered with papers and books. After they were married, Frederic went to Paris and wrote to Amelie that he had accepted a job there, and when he got back home, they would move to Paris. Her letter to him stated in no uncertain terms that she was very disappointed that he did not consult with her about this. That marriage was a partnership, and they need to make all of these decisions in the future.

And we are trying to make this guy a saint... Makes us more hopeful of our chance at sainthood.



# TWINNING - Needed Now More Than Ever

Twinning is when a conference sends unrestricted money to another SVdP organization. Some conferences with extra funds send them to the Hope Conference, to nearby conferences, to conferences across the county or to conferences in other countries. However a conference wants to use their surplus funds is the conference's decision. However if it twins outside the USA it must go through National.

Right now, a lot of conferences, including Hope, are very low on funds. If your conference has extra funds please consider twinning. Steve Krank can always give you advice on which conferences are in need.

HOWEVER, always keep in mind that we cannot do it all. As much as it hurts our neighbors in need and our hearts, sometimes we have to tell them that we simply cannot help them financially. What we can do is listen to them, pray with them, offer some suggestions and maybe give them some hope. That's easier to say than do, but I did it half a dozen times last week, when I was responding to messages on my conference's phone line. Surprisingly many of them told me that they understood and thanked be profusely for at least taking the time to respond to their call.

PLEASE NOTE: If your conference sends money to another conference for a specific neighbor in need that is not twinning. That should be treated exactly as if your conference helped the neighbor directly. While your conference may be writing a check to another conference, which will pay the rent or utility bill, treat it the same as if your conference is writing the check to the landlord or the utility company. This is how National wants it handled. **Bob** 



# More on Twinning and Addressing the Urgent Need for Support in Our Community

### Conference Presidents,

I hope you're doing well and staying healthy. I am writing on behalf of the St. Paul Conference of the Society of St. Vincent de Paul to ask for your help. Their mission to serve the vulnerable in our community is more critical than ever, and we believe that with your assistance, we can continue to make a meaningful impact.

While the pandemic may be in the past, the pressing need to assist our neighbors continues to grow. Increasingly, families are turning to our SVDP Conferences not just for food aid, but also for rent and utility assistance. The magnitude of this need can be emotionally, spiritually, and financially overwhelming, making it crucial that we unite to support both our families and fellow conferences. Here are several ways we can achieve this:

- 1. Financially stable conferences can provide twinning from their treasuries to conferences in greater need. These twinning donations can be made on an as-needed, monthly, or annual basis.
- 2. Conferences can request assistance from other conferences through co-pay arrangements for individual cases where resources are insufficient.
- 3. When a conference lacks the resources to provide rent and utility assistance independently, applications can be submitted to the Hope Conference to maximize support for families.

Now, I want to emphasize the urgency of the situation. The St. Paul Conference is a Vincentian Conference without access to full-service resources.

Last month, at all the Masses, they hosted an Invitation to Serve both in English and Spanish over the weekend. The appeal reached out to invite new members to grow in Holiness and provide the help they desperately need. "With more Vincentians, our burden is shared."

Most Bay Area residents do not know that San Pablo has the highest density of new immigrants in the Bay Area, is still one of the largest areas where the unhoused have found a place to camp, and St. Paul's in their service includes the "Iron Triangle" area that was left with a major void when St. David's Pantry closed.

Even the Contra Costa County Health Care for the Homeless, acknowledging the plight of our neighbors living in the area, has set up a permanent site at the GRIP Dining Room to keep our neighbors from going over the edge.

In light of these challenges, the St. Paul Conference's financial resources are dwindling rapidly, and they are eagerly awaiting the announcement of the FOP Grant next month, which will determine whether they will receive the support we desperately need.

In the meantime, they have faced the difficult decision of reducing their food service from four times a month to just two times a month in November and December. (Seasonally, these are some of the most significant months of the year when low-income families need help). This temporary measure will help them bridge the gap until they secure support from the Food Bank.

Moreover, they have reached out to local Conferences who do what they can to help. "We hope that this support remains available to us. Our conference recently conducted a food sale event to raise funds for a much-needed refrigerator." Any support you and other conferences can provide would be immensely appreciated during this challenging period.

### **Good Stewardship and Twinning**

To identify cases where families are seeking assistance from multiple conferences, we can use the Seattle Database, which allows us to search our records and those of other conferences. An increasing number of conferences are using this tool to make informed decisions on assistance allocation. Collaborating with other conferences will help us leverage our resources and provide better support to our neighbors in need.

In conclusion, we appreciate your time and consideration of our appeal. May God continue to bless us all and provide us with the love and strength to serve those in need.

Now, let's come together to address this pressing need. Would you be willing to share this article with your Conference and prayerfully consider what we might be able to do together to support the St. Paul Conference?

Thank you again for your unwavering support and dedication to the Society of St. Vincent de Paul. Together, we can make a significant difference in each other's lives and also in the lives of those we serve.

### **HELP HOPE HELP OUR NEIGHBORS**

- 1. Hope Conference needs to be ensured that conferences are going to other sources for rental assistance before applying to the Hope Conference. If they have, and are not able to get assistance from other sources, it is essential that the application notes this. Then it will be clear to us that they have tried other sources, and why they were not able to get assistance from them.
- 2. When it comes to Utilities, the same as above should be noted. We should not get an application for utilities until all the other resources for utility assistance have been requested from other agencies. We get the request only after they have applied and been turned down.
- 3. All listed income needs to have supporting documentation, i.e., pay stubs, child care docs, CalFresh approval letter, etc.
- 4. You need to ensure that when entering expenses as 'Other' it needs to be clear what the 'Other' expenses are. Also, ensure that all expenses are listed.
- 5. Documents must be readable. If you cannot read them neither can we. The best way to put the documents into the application is to scan them. (If you have a cell phone then you are able to scan documents. If you need help; we will help you learn how to scan).
- 6. Many times, the Application has not been signed by the neighbor, and the Release of Information is not signed by the home visitor (case worker).
- 7. We do not require Social Security cards.
- 8. **This is important.** Section 4 of the application needs to have the amount of assistance that has been applied for, and that the payee section be completed. If this information is not on the application then we cannot write a check to pay the request. (You call and ask why the bill has not been paid? We might have no address or the wrong address, and then the check is floating around somewhere. We need to know where to send the check.) We get charged \$35.00 to stop payment on a check and from now on we are going to have the applying conferences pay this amount.
